Smoke Free Laws

- 24 states, along with the District of Columbia, Puerto Rico, and the U.S. Virgin Islands, have laws in effect that cover ALL workplaces, restaurants, and bars to be 100% smoke free.
- These laws, along with local laws in other states, protect 49.1% of the U.S. population.
- Comprehensive: workplaces, restaurants, bars, etc...

Regional smoke free work

- Statewide laws with restaurants & workplaces only:
 - Louisiana
 - Arkansas (small business exemption)
- No statewide law/Strong local laws/ Population covered:
 - Mississippi: 82 local laws, 29% population covered
 - Alabama: 26 local laws, 11% population covered
 - Missouri: 26 local laws, 24% population covered
 - Oklahoma (has preemption = no local laws)



Smoke Free Gaming



Tobacco taxes

- Average State Cigarette Tax: \$1.53 per Pack
- Average Cigarette Tax in Major Tobacco States:
 48.5 cents per Pack
- Average Cigarette Tax in Non-Tobacco States:
 \$1.67 per Pack

Texas Tobacco Control Funding

- FY2014 <u>State</u> Funding for Tobacco Control Programs: \$11,201,794
- FY2014 Federal Funding for State Tobacco Control Programs: \$4,150,819*
- FY2014 Total Funding for State Tobacco Control Programs: \$15,352,613
- CDC Best Practices State Spending Recommendation: \$266,300,000
- Percentage of CDC Recommended Level: 5.8%

Texas Cessation Coverage: State Medicaid Program

- Medications: Covers NRT Gum, NRT Patch,
 Varenicline (Chantix) and Bupropion/Zyban
- Counseling: Covers phone counseling; coverage of individual and group counseling varies by health plan
- Barriers to Coverage: Minimal co-payments required for medications; co-payments for counseling vary by health plan

Texas Cessation Coverage: State Employee Health Plans

- Medications: Covers Bupropion/Zyban and Varenicline (Chantix)
- Counseling: All health plans cover online counseling; some plans cover group and phone counseling
- Barriers to Coverage: Co-payments required

Texas State Quitline

- Investment Per Smoker: Data not reported
- CDC recommends an investment of \$10.53/smoker

Highlights: Cessation Coverage

- Medicaid enrollees still do not have access to all the help they need to quit. Only two states provide a comprehensive tobacco cessation benefit to Medicaid enrollees.
- Only four states provide a comprehensive tobacco cessation benefit to state employees.
- State quitlines remain chronically underfunded.
 On average, states invested only \$3.76 per smoker in quitlines in fiscal year 2014.

 - Increased Tobacco taxes
